# ROAD TRAFFIC (MISCELLANEOUS AMENDMENTS) REGULATIONS, 2012

The Minister, in exercise of the powers conferred on him by section 124(1)(t) of the Act, makes the following Regulations:

- 1. These Regulations may be cited as the Road Traffic (Miscellaneous Amendments) Regulations, 2012.
