All corporate applications must include with the application a copy of the company's Certificate of Incorporation as evidence of the fact that the company is an existing registered company as at the date of the application. The Certificate must be in the name of the applicant. Local applicants are advised that the Certificate of Incorporation referred to above means a Certificate of Incorporation issued under the 1985 Companies Act of Barbados or where applicable a Certificate of Amendment. Certificates must be dated after December 31, 1984.
4. Any company incorporated outside of Barbados which is awarded a contract will be required to be registered in Barbados as an external company under the Companies Act of Barbados and produce a performance bond.

APPLICANTS SHOULD BE AWARE THAT THE LABOUR CLAUSES (PUBLIC CONTRACTS) ACT CAP. 349 SHALL IN SO FAR AS IT IS APPLICABLE TO THE SUBJECT OF THE TENDER, APPLY TO ANY CONTRACT MADE IN RESPECT OF THE TENDER.
